SRO 940 .- In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor is pleased to direct that the prosecution cadre of the Jammu and Kashmir Police (Non-Gazetted) Service for the Union Territory of Jammu and Kashmir upon exclusion of the posts of Union Territory of Ladakh, shall comprise the posts as indicated in Schedule-I to this notification, subject to any modifications as may be necessary.

This shall come into force with immediate effect.




