S.O. 25.- In exercise of the powers conferred by clause (ii) of sub-section (b) of section 3 of "the Prohibition of Electronic Cigarettes (Production, Manufacture, Import, Export, Transport, Sale, Distribution, Storage and Advertisement) Ordinance, 2019 (No. 14 of 2019), the Lieutenant Governor hereby directs that the following Drugs Control Officers of Drugs and Food Control Organization shall be the "**Authorised Officer**" for the purposes of the Act within the territorial jurisdiction of the Union Territory of Jammu and Kashmir; namely:-


