Subject: Final combined Seniority list of Junior Assistants of the Jammu and Kashmir Legal (Subordinate) Service as it stood on 01-01-2025.

Whereas, a separate(cadre wise) tentative seniority list of Junior Assistants of the Department of Law, Justice and Parliamentary Affairs was issued in terms of Annexure J,K,L and M to the Circular No. 02-JK(LD) of 2024 dated 11-01-2024 for inviting objections from the concerned Officials, if any, within a period of 07 days from the date of issuance of the said circular;

Whereas, number of objections have been received in the Department from the members of the Service;

Whereas, vide Government Order No.10769-JK(LD) of 2024 dated 12-06-2024 read with Government Order No. 11691-JK(LD) of 2024 dated 28-06-2024, a committee of three (03) Officers, was constituted by the Department, for examining the aforesaid objections. The committee submitted its report/recommendations vide its communication dated 15-10-2024 and has observed that a separate seniority (cadre wise) is likely to throw legal conundrum for the Department on the count of the uneven distribution of posts in the Part-B of Schedule-I of the J&K Legal (Subordinate) Service Recruitment Rules, 2021 between different cadres. As such, has recommended for issuance of a combined seniority list in order to address the issue in right earnest;

Whereas, 57 officials have submitted representation dated 04-06.2025, furnishing there NOC and requesting to fix their seniority combined taking into consideration the length of service in the cadre, date of regularization/confirmation and merit obtained by them in the selection process conducted by Service Selection Board, as some of the Officials of the service have been promoted as Junior Assistants from time to time by DPC and some have been appointed on the recommendations of JKSSB;

Whereas, upon examination of the aforesaid recommendation of the Committee and having due regard to the representation/NOC submitted by the members of the service, it has necessitated drawing up

of a combined seniority list of Junior Assistants for equitable chances of promotion of all cadres and will also address the long pending stagnation of all these officials;

Whereas, this Department before issuing the final combined seniority list had issued a combined tentative seniority list of Junior Assistants of the Department of Law, Justice and Parliamentary Affairs in terms of Circular No. 10-JK(LD) of 2025 dated 18-06-2025 for inviting objections from all the concerned Officials, if any, within a period of 07 days from the date of issuance of the said circular;

Whereas, number of objections have been received in the Department from the members of the J&K Legal (Subordinate) Service and members of erstwhile State Human Rights Commission;

Whereas, upon examination of the aforesaid objections, Department found no merit in them in light of the aforesaid detailed position and were accordingly rejected/disposed of;

Now, therefore, in view of above, a combined final seniority list of the Junior Assistants of the J&K Legal (Subordinate) Service as it stood on 01-01-2025, forming "**Annexure A**" to this Order is hereby issued/ notified for information of all concerned officials. The Combined seniority list of the officials is issued strictly on the basis of the date of first substantive appointment /regularization in-terms of the Rule 24 of the Jammu and Kashmir Civil Services (Classification Control and Appeal) Rules 1956.

The Date of Birth and Category status of the officials recorded in the final seniority list shall not be construed as authentic and shall be subject to further verification with the Service Book/ Matriculation Certificate/ valid Category Certificate issued in respect of these officials by the concerned authorities.

The Seniority list notified shall be without prejudice to the final outcome of Writ Petition(s)/O.A, if any, pending before any competent court of Law/ Tribunal.
